# UPPER MOUNT BETHEL TOWNSHIP BOARD OF SUPERVISORS MEETING MINUTES MONDAY, JULY 12, 2021 – 7:00 PM

Chairman Pinter called the meeting to order at 7:00 pm.

The Pledge of Allegiance was recited.

Present were Chairman Pinter, Supervisor Due, Supervisor Bermingham, Supervisor Teel, Supervisor DeFranco, Township Manager Nelson, and Township Solicitor Karasek. Township Engineer Coyle was absent.

Chairman Pinter stated that the streaming card was fried from a recent storm, therefore, tonight's' meeting will not be live streamed.

### Public Comments:

Charlie Cole, River Rd., commented on the EDC survey, how it is poorly written, and the status of it being active.

John Corica, Shepherds Hill, commented on the condition of his neighborhood, poor road conditions, overgrown empty lots, and no communication with the developer. John commented on the Firearms Ordinance and stated it is mistake.

Richard Wilford-Hunt read his public comment, which will become part of the official record. Richard commented on the behavior of the Supervisors towards Supervisor Bermingham, the EDC survey, the frustration of the residents of UMBT and the proposed Industrial Park Committee. Chairman Pinter stated he is looking for "balance", in the committee, not to disband it. Supervisor Bermingham stated the committee is still moving forward. Supervisor Teel stated he is not a self-proclaimed liaison.

# V. SUBDIVISIONS

1. 1596 & 1608 Potomac St. Lot Line Adjustment Plan-Solicitor Karasek stated the Township's Planning Commission has recommended approval of the Plan based upon Engineer Coyle's recommendation letter dated April 13, 2021, along with the SALDO waiver approved by the BOS. **MOTION** by Supervisor Teel to approve the Preliminary Conditional Final Plan for 1596 & 1608 Potomac St. Lot Line Adjustment, seconded by Supervisor Due. Vote: 5-0.

# VI. SITE PLAN

1. 49 Saddle Creek Modification-Solicitor Karasek discussed Engineer Coyle's review letter dated June 14, 2021, recommending a modification to the approved plan be allowed for the construction of the proposed dwelling, driveway and stormwater features within the easement as proposed. The applicant will be responsible for submitting a statement, certified by their Engineer, verifying all stormwater and grading was completed as per the approved Site/Grading Plan. The Township Planning Commission recommends

the modification. **MOTION** by Supervisor Teel to approve the 49 Saddle Creek Modification, seconded by Supervisor DeFranco. Vote: 5-0.

- 1. Social Media/Privacy Policy-Manager Nelson asked the Board to review the proposed Social Media Policy that is in their binders and to send any questions or comments to him. Solicitor Karasek stated he will review and should be able to speak on it at the next meeting. **MOTION** by Supervisor DeFranco to table to the next meeting, seconded by Supervisor Teel. Vote: 5-0.
- 2. River Road Roadway and Embankment Repairs-Manager Nelson spoke on behalf of Engineer Coyle. Bids were received and Engineer Coyle recommends rejecting the bids received. Manager Nelson stated the Township also put together a bid for the project and stated the project can be completed for about \$38,603, since a lot of the material we have in stock. Chairman Pinter would like to know a true cost. Manager Nelson stated he will get that to the Board.

  MOTION by Supervisor Due to reject the bids, as per Engineer Coyle's recommendation, seconded by Supervisor Bermingham. Vote: 5-0.

Chairman Pinter stated the Union Contract was discussed and stated there are some other burden costs the Township would like to see before they vote on it, therefore, this will be tabled for 30 days for Manager Nelson to work with the Union Rep to gather the information needed. **MOTION** by Supervisor Teel to table for 30 days, seconded by Supervisor Due. Vote: 5-0.
