UPPER MOUNT BETHEL TOWNSHIP BOARD OF SUPERVISORS REORGANIZATION MEETING MINUTES TUESDAY, JANUARY 2, 2024 - 7:00 PM

*This meeting was held in-person and live streamed through the Upper Mount Bethel Township Facebook page.

Supervisor Bermingham called the meeting to order at 7:00 pm. The Pledge of Allegiance was recited.

Present were Supervisor Bermingham, Supervisor Friedman, Supervisor Eckman, Supervisor Albert, and Township Manager Graziano.

Appoint Recording Secretary-2024-**MOTION** by Supervisor Friedman to appoint Cindy Beck as Recording Secretary for the Board of Supervisors and Planning Commission for 2024, seconded by Supervisor Eckman. Vote: 4-0.

At this time, Newly Elected Supervisor Cori Eckman took her Oath of Office:

Bethel, Pennsylvania, being duly elected or appointed Supervisor of Upper Mount Bethel Township, in Northampton County, Pennsylvania, do solemnly swear that I support, obey, and defend the Constitution of the United States of America and the Constitution and Laws of the Commonwealth. That I will perform the duties of my appointment with fidelity, that I will not knowingly receive, directly or indirectly, any money or other valuable thing things for the performance of or non-performance of any act or duty pertaining to my appointment, other than the compensation allowed by law.

Cori signed the Oath of Office and Secretary Cindy Beck notarized it.

PUBLIC COMMENT-Supervisor Bermingham stated that moving forward, there will be two public comment periods. The first public comment period is for commenting on anything on the agenda and the second public comment period will be for anything you'd like to comment about. Public comment will be 4 minutes and the Board will also answer questions.

Judith Henckel, Robin Hood Road, thanked the new Board and good to see a change. Mark Mezger, Scenic Court., thanked the new Board and good to see a change.

Richard Wilford-Hunt, Shady Lane, thanked Supervisor Eckman and Supervisor Albert for taking the new seats and Supervisor Bermingham and Supervisor Friedman for continuing to listen to the residents. Richard stated that he hopes the developer will start to work with us.

Michael Onufrak, Summerfield Drive, congratulated Supervisor Eckman and Supervisor Albert and wishes them the best.

Charles Cole, Riverton Road, commented on the open Supervisor seat. Supervisor Friedman discussed the process of appointing a Supervisor. There is timeframe for a resignation to be effective, if accepted, the Board has 30 days to appoint a new Supervisor. If the resignation is not accepted, the timeframe begins when the letter was submitted, then after 45 days, the Board has 30 days to appoint a new Supervisor.

John Kalena, Ridge Road, asked if David Due was still a Supervisor. Supervisor Friedman stated that yes, technically he is still a Supervisor.

Supervisor Bermingham thanked Lee McDonald for live-streaming tonight's' meeting.

Frances Visicaro, N. Delaware Drive, thanked the Board and stated that there will be times where their votes will be difficult to make because of the law. Supervisor Bermingham stated that communication is the key, whether through social media or office hours.
