UPPER MOUNT BETHEL TOWNSHIP BOARD OF SUPERVISORS ANNUAL REORGANIZATION MEETING MINUTES MONDAY, JANUARY 4, 2021 @ 7:00 PM

*This meeting was held virtually and live streamed through the Upper Mount Bethel Township Facebook page.

- 1. Call to Order-Chairman Bermingham Jr. called the meeting to order at 7:00 pm.
- 2. The Pledge of Allegiance was recited.
- 3. Roll Call-Virtually present were Chairman Bermingham Jr., Supervisor Teel, Supervisor Due, Supervisor Pinter, Supervisor DeFranco and Township Manager Nelson.
- 4. Public Comment-None
- 5. Appoint Recording Secretary-2021-MOTION by Chairman Bermingham Jr. to appoint Cindy Beck as Recording Secretary for the Board of Supervisors and Planning Commission for 2021, seconded by Supervisor Teel. Vote: 5-0.

- 1. APPOINT TEMPORARY CHAIRMAN-MOTION by Supervisor DeFranco to appoint Stavros Barbounis as temporary Chairman, seconded by Supervisor Due. Vote: 5-0.
- 2. APPOINT CHAIRMAN-MOTION by Supervisor Teel to appoint <u>Martin Pinter</u> as Chairman to the Board of Supervisors, seconded by Supervisor Due. Vote: 4-0-1. Chairman Pinter abstained.
