UPPER MOUNT BETHEL TOWNSHIP PLANNING COMMISSION MEETING MINUTES WEDNESDAY, AUGUST 18, 2021 – 7:00 PM

Chairman Teel called the meeting to order at 7:00 pm.

The Pledge of Allegiance was recited.

Present were, Chairman Teel, Commissioner DeFranco, Commissioner Klein, Engineer Coyle, and Solicitor Karasek. Absent were Commissioner Crane and Commission Sarisky.

Approve the Minutes-**MOTION** by Commissioner DeFranco to approve the July 21, 2021, Meeting Minutes, seconded by Commission Klein. Vote: 3-0.

SUBDIVISIONS

a. Steven B. Ott 905-907 Sunset Dr. Minor Subdivision-Engineer Coyle discussed the plan. Engineer Coyle stated the intent is to subdivide the existing lands to create a 1.87-acre lot which will encapsulate an existing dwelling, barn, and garage. This will result in a 111.43-acre parcel of which 107.42 acres are to remain in an Agricultural Conservation Easement and no development or public improvements are proposed. The proposed lot is located in the A-1 zoning district, where the minimum lot size is to be 2.0 acres, Solicitor Karasek stated that this will be a zoning issue, that he may need to go before the ZHB and claim hardship. Commission DeFranco stated

a letter from Maria Benzoni stating that this plan is approved by the County Farmland Preservation, should be a condition on approving this plan. **MOTION** by Commission Klein for the County to approve of the subdivision as a condition, seconded by Commission DeFranco. Vote: 3-0. Engineer Coyle stated there are no SALDO waivers in letter format requested. Solicitor Karasek discussed the conditional list: letter from Farmland Preservation, written SALDO waiver (400.4.5) request, Open Space Dedication or Fee in Lieu (1-lot \$2,000). **MOTION** by Commission Klein to grant the scale waiver of 1"-200 ft., seconded by Chairman Teel. Vote: 3-0. **MOTION** by Commission DeFranco to table, seconded by Commission Klein. Vote: 3-0. -Official Action expires on October 19, 2021
